RESOLUTION TO APPROVE/REJECT A BOARD OF COMMERCE AND INDUSTRY APPROVED APPLICATION FOR AN INDUSTRIAL TAX EXEMPTION BY ALLPAX PRODUCTS, LLC.

WHEREAS, ALLPAX Industrial Products, LLC has filed an application with the Louisiana Economic Development for a tax exemption under the Industrial Ad Valorem Tax Exemption Program (ITEP), post Executive Order 2018; and

WHEREAS, the Rules of the Board of Commerce and Industry (the Board), effective August 20, 2018, specifically Title 13 of the Louisiana Administrative Code, Sec. 503(H)(1) ("Rule") indicate that upon the Board's approval of an application, the department, on behalf of the board, shall, within three business days transmit a copy of the approval and Exhibit A by mail or electronic mail to each local governmental authority and the assessor within three business days of approval, and

WHEREAS, St. Tammany Parish Government received said notification on December 17, 2019; and

WHEREAS, pursuant to the ("Rule") St. Tammany Parish Government has a notice period of 30 days for the Parish governing authority (speaking on behalf of the Parish and all Parish bodies who are located outside the boundary of any affected municipality who receive a millage) to initiate action to approve or reject the board's action; and

WHEREAS, within the 30 day notice period, the Parish governing authority may identify the application on the agenda of a public meeting notice approving or denying the application, and notice of this action shall be given to the department within 3 business days and allows for an additional 30 days (fro a total of 60 days from the start of the notice period) to conduct a public meeting issuing a resolution approving or rejecting the board approved application.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES to approve/reject ALLPAX Products, LLC's Tax Exemption Program Application.
