RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A SIDEWALK AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR INSTALLATION OF SIDEWALKS IN CONJUNCTION WITH THE CONSTRUCTION OF THE HIGHWAY 59 CURVE REALIGNMENT AND TUNNEL AT THE INTERSECTION OF HIGHWAY 59 AND THE TAMMANY TRACE (WARD 4, DISTRICT 5).

WHEREAS, the State of Louisiana, Department of Transportation and Development ("DOTD") seeks to construct or have constructed a curve realignment and tunnel at or near the intersection of Highway 59 and the Tammany Trace; and

WHEREAS, in conjunction with the construction, St. Tammany Parish Government has requested that DOTD install a one or more sidewalks in the project area to facilitate pedestrian and cyclist traffic; and

WHEREAS, St. Tammany Parish Government desires that DOTD install one or more sidewalks in the project area comprising the Highway 59 curve realignment and tunnel construction, with Parish providing reimbursement for the costs of same.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to enter into a Sidewalk Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development, for installation of one or more sidewalks in conjunction with the construction of a curve realignment and tunnel at the intersection of Highway 59 and the Tammany Trace and to take any and all actions necessary to enter into the Sidewalk Agreement in support of the construction.
