AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE LIVE OAK LOOP LATERAL; OAKLEY PLACE SUBDIVISION, PHASE 1, SPECIFICALLY LEIGHTON COURT; LEIGHTON COURT LATERAL; OAKLEY BOULEVARD; AND AN EXTENSION TO ABNEY FARM ROAD. (WARDS 6 & 8, DISTRICTS 6 & 9)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include Live Oak Loop Lateral (D06OW01034), approximately 914 feet, located east of Live Oak Loop (R06O034) and north of Oak Knoll Road (R06O032), Ward, 6, District 6; and
2. Include Leighton Court (R08H056), approximately 565 feet, located Off Oakley Boulevard (R08H055), Ward 8, District 9; and
3. Include Leighton Court Lateral (D08HW01056), approximately 1,050 feet, located off Leighton Court (R08H056) between address 620 and 624 running east for approximately 140 feet then north, Ward 8, District 9; and
4. Include Oakley Boulevard (R08H055), approximately 500 feet, located off Abney Farm Road (R08H023), Ward 8, District 9; and
5. Include an extension of Abney Farm Road (R08H023), approximately 1,405 feet, located off Robert Road/Highway 1091, Ward 8, District 9.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
