AN ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 20, ROADS AND BRIDGES, ARTICLE I, IN GENERAL, BY CREATING A NEW SECTION, PROCEDURES AND SPECIFICATIONS RELATIVE TO PARISH ROAD OVERLAY PROJECTS AND CAPITAL ROAD PROJECTS.

WHEREAS, in order to provide additional notice to the Parish Council members relative to asphalt road overlays in their respective District;

WHEREAS, a procedure for the notification will assist all included in the process;

WHEREAS, due to the unique conditions in each district, input on the type of and quality of the asphalt used in the overlay is sometimes critical.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that It hereby amends the Parish Code of Ordinances, Chapter 20, Article I, In General, and establishes the new Section, Procedures and Specifications Relative to Parish Road Overlay Projects and Capital Road Projects, as follows, to wit:

PROCEDURE AND SPECIFICATIONS RELATIVE TO PARISH ROAD OVERLAY PROJECTS AND CAPITAL ROAD PROJECTS

(a) ~~The bid specifications including the type of asphalt to be used for Parish road overlay projects in each Council District and Capital Road Projects funded by District Capital allocations shall be approved by the Parish Council member of each said respective District in consultation with the Parish Engineer and Public Works Director. only permit the use of Superpave asphalt in bidding projects on roads that meet or exceed an average daily traffic count of fifteen ten thousand (15,000 10,000) vehicles as determined by the use of approved counting methods, otherwise, Type 3 Virgin Asphalt shall be used.~~

(b) Written Notice of the type of asphalt to be used on any Parish road overlay project shall be directly given to the Council person representing the District in which the project is to occur by email at least ten (10) days prior to the bid specifications becoming part of the formal bid request.

~~During said ten (10) day period the Council person may issue a formal request for a clarification and/or for a change in said specifications to the Procurement Office with a copy to the Parish President.~~

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
