AN ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 24 MOTOR VEHICLES AND TRAFFIC, ARTICLE III OPERATION ON PRIVATE ROADS AND SUBDIVISIONS, SEC. 24-68 VIOLATIONS.

WHEREAS, in order to provide for a more efficient process to pay fines and fees associated with traffic violations in private subdivisions it is necessary to amend the fee structure currently provided for; and

WHEREAS, a flat fee, rather than a range of fees, would allow those violators who wish to pay the levied fine without contest to do so online or in person, without having to appear in Misdemeanor Court.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it hereby amends the Parish Code of Ordinances, Chapter 24 Motor Vehicles and Traffic, Article III Operation on Private Roads and Subdivisions, Sec. 24-68 Violations as follows:

**Sec. 24-68 Violations**

Whoever violates the provisions of this article shall be guilty of a misdemeanor and shall be fined ~~not more than \$ 100.00 or imprisoned for not more than 30 days, or both, in the discretion of the court~~ \$ 75.00 plus court costs in the amount specified by the 22nd Judicial District Court Costs Schedule according to the violation.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
