AN ORDINANCE ESTABLISHING A NO PARKING ZONE ON PORTIONS OF QUEEN ANN DRIVE AND RALEIGH DRIVE IN HUNTWYCK VILLAGE SUBDIVISION. (WARD 9, DISTRICT 11)

WHEREAS,

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I: A "NO PARKING ZONE" is hereby established on portions of Raleigh Drive (R09G036) and Queen Anne Drive (R09G038) within Huntwyck Village Subdivision, specifically, the 300 block of Raleigh Drive, and the 300 block and 500 block of Queen Anne Drive for the widths of the parks. (Ward 9, District 11)

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
