ORDINANCE TO AMEND ORDINANCE C.S. NO. 83-639 (ADOPTED 7/12/1983), ORDINANCE C.S. NO. 96-2513 (ADOPTED 10/17/1996) AND ORDINANCE C.S. NO. 97-2575 (ADOPTED 1/16/1997) FOR AMENDING THE BOUNDARIES OF ST. TAMMANY PARISH LIGHTING DISTRICT NO. 7.

WHEREAS, St. Tammany Parish Lighting District No. 7 was created and boundaries established pursuant to Ordinance No. 83-639 and thereafter amended by Ordinance C.S. No(s). 96-2513 and 97-2575, said ordinances being codified in the Parish Code of Ordinances as sections 20-207.00 and 20-207.01; and

WHEREAS, there is a need to expand the southern boundary of Lighting District No. 7 to include that portion of Lake Pontchartrain up to the southern boundary of St. Tammany Parish, which is otherwise contiguous to the existing southern boundaries of Lighting District No. 7; and

WHEREAS, attached as Exhibit "A" is a map showing the proposed boundaries of Lighting District No. 7 as amended herein.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the boundaries of Lighting District No. 7 are hereby amended to include certain portions of Lake Pontchartrain beyond the natural shoreline to the southern boundary of St. Tammany Parish, all as more fully shown on the attached Exhibits; and

BE IT FURTHER ORDAINED that Section 20-207.00 of the Parish Code of Ordinances be amended as follows:

There is hereby created St. Tammany Parish Lighting District No. 7. The boundaries of such district shall be the entirety of Precinct 9 of the Ninth Ward, with the inclusion of the roads and/or pieces of roads described below in Sec. 20-207.01, and, further, with the inclusion of all of Lake Pontchartrain South of Precinct 9 of the Ninth Ward extending (a) due South from the westernmost intersection of Precinct 9 of the Ninth Ward with the shoreline of Lake Pontchartrain to the southernmost boundary of St. Tammany Parish; and (b) due South from the easternmost intersection of Precinct 9 of the Ninth Ward with the shoreline of Lake Pontchartrain to the southernmost boundary; and (c) that portion of the southern boundary of St. Tammany Parish between (a) and (b) above.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

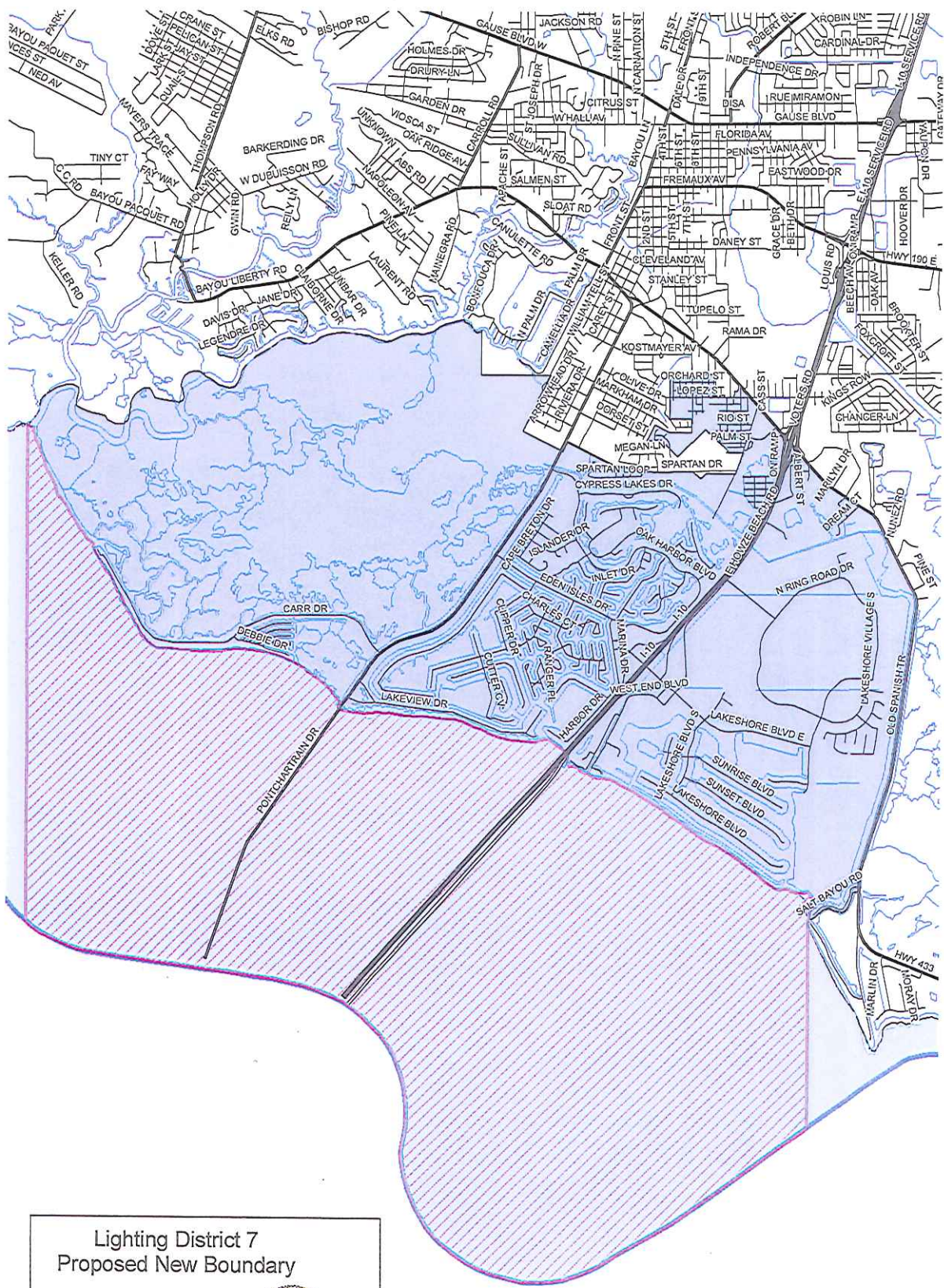
