RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH BUSH FOOD PANTRY, INC. TO PROVIDE FUNDING FOR THE OPERATION OF A FOOD BANK.

WHEREAS, Bush Food Pantry, Inc. operates the "Bush Food Pantry," providing food assistance and personal hygiene products to qualified low-income families; and

WHEREAS, the Parish desires to provide funding resources to support the Bush Food Pantry.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with Bush Food Pantry, Inc. for funding support of its "Bush Food Pantry," and to take any and all actions necessary in support of same.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

St. Tammany Parish Government is seeking to enter into a Cooperative Endeavor Agreement in order to provide calendar year 2016 funding for Bush Food Pantry, Inc. Funding source is the public health tax, and funding for the 2016 calendar year is \$25,000.00.
