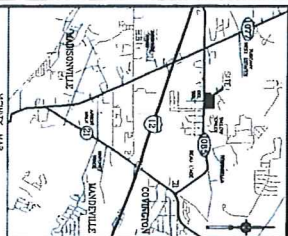
This office has inspected the site. All work covered by this Warranty Obligation is satisfactory.

ST. TAMMANY PARISH, LOUISIANA

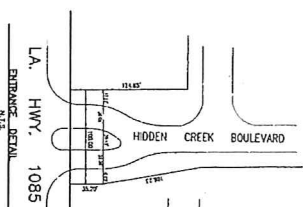
