## **Ordinance Administrative Comment**

ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO AN ASSET TRANSFER AGREEMENT WITH CENTERPOINT ENERGY FOR NATURAL GAS SERVICE TO THE SAFE HAVEN FACILITIES (WARD 4, DISTRICT 7)

The Parish seeks to have CenterPoint Energy, or an affiliated entity, assume operation and maintenance of the natural gas lines on the Safe Haven campus. This will include separate metering of the buildings on the campus. As the natural gas lines are presently deemed owned by Parish and not previously claimed or operated by CenterPoint Energy, an Asset Transfer Agreement is necessary to place CenterPoint Energy in ownership.
