TAMMANY PARISH, LA, TO RECLASSIFY A CERTAIN PARCEL LOCATED ON THE WEST SIDE OF CHRIS KENNEDY ROAD, NORTH OF TED KENNEDY ROAD AND WHICH PROPERTY COMPRISES A TOTAL 0.460 ACRE OF LAND MORE OR LESS, FROM ITS PRESENT A-2 (SUBURBAN DISTRICT) TO AN A-2 (SUBURBAN DISTRICT) & RO (RURAL OVERLAY).
