RESOLUTION TO APPROVE AND AUTHORIZE ST. TAMMANY PARISH THROUGH THE OFFICE OF PARISH PRESIDENT TO SIGN AND/OR EXECUTE A UTILITY SERVICE AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND WILLIAM JOHNSON FOR THE PURPOSE OF PROVIDING WATER AND SEWERAGE SERVICES TO A PORTION OF NORVAL STREET.

WHEREAS, St. Tammany Parish desires to enter into a Utility Service Agreement with William Johnson ("Developer") to provide the water and sewer service for Developer's site on Norval Street between Molitor and Dupree Streets; and

WHEREAS, Developer will install the water and sewer lines and related equipment needed to connect to Parish's existing water and sewer lines, at Developer's expense and as more fully described in the Utility Service Agreement to be effected; and

WHEREAS, upon completion and acceptance of the water and sewer lines and related equipment, Developer will donate said lines and equipment to the Parish, as more fully described in the Utility Service Agreement to be effected.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/or execute a Utility Service Agreement between St. Tammany Parish and William Johnson regarding the provision of water and sewer services and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
