RESOLUTION TO APPROVE AND AUTHORIZE THE PARISH OF ST. TAMMANY THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND GRACE MEMORIAL BAPTIST CHURCH FOR EMERGENCY SHELTERING DURING AN EMERGENCY.

WHEREAS, St. Tammany Parish desires to enter into an agreement with Grace Memorial Baptist Church to provide emergency sheltering for its citizens during an emergency; and

WHEREAS, St. Tammany Parish's obligations under said agreements shall include the delivery of provisions to Grace Memorial Baptist Church, when such provisions are made available by the Red Cross; and

WHEREAS, St. Tammany Parish desires to enter into a Cooperative Endeavor Agreement to prepare for the emergency sheltering of its citizens; and

WHEREAS, Cooperative Endeavor Agreements are authorized pursuant to Article VII Section 14(c) of the Louisiana State Constitution which authorizes governmental entities to enter into cooperative endeavor agreements.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement between St. Tammany Parish and Grace Memorial Baptist Church in furtherance of the objectives stated above and to provide emergency sheltering during an emergency.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
