A RESOLUTION APPROVING THE HOLDING OF AN ELECTION IN FIRE PROTECTION DISTRICT NO. 7 OF THE PARISH OF ST. TAMMANY, LOUISIANA, ON SATURDAY, DECEMBER 10, 2016, TO AUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN.

WHEREAS, the Board of Commissioners of Fire Protection District No. 7 of the Parish of St. Tammany, Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 7 of the Parish of St. Tammany, Louisiana (the "District"), plans to call a special election in the District on Saturday, December 10, 2016, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to further approve the levy and collection of the special tax provided for therein;

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 7 of the Parish of St. Tammany, Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, December 10, 2016, at which election there will be submitted the following proposition, to-wit:

PROPOSITION (MILLAGE RENEWAL)

Shall Fire Protection District No. 7 of the Parish of St. Tammany, Louisiana (the ADistrict@), levy a special tax of five and twenty-one hundredths (5.21) mills on all property subject to taxation within the District (an estimated \$ 200,585 reasonably to be expected at this time to be collected from the levy of the tax for an entire year) for a period of ten (10) years, beginning with the year 2017and ending with the year 2026, for the purpose of acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment in and for the District, including the cost of obtaining water for fire protection purposes?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to levy and collect the special tax provided for therein.
