AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE KISSENA PARK LATERAL; WILDWOOD DRIVE LATERAL; PATRICK ROAD LATERAL; GREEN HILL DRIVE LATERAL; AND AN EXTENSION TO ROSEDOWN WAY LATERAL. (WARDS 1, 2, 5 & 10, DISTRICTS 2, 3 & 6)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Kissena Park Lateral (D10DW01021), approximately 1,240 feet, located west off end of Kissena Park Road (R10D021), Ward 10, District 6; and

2. Add Wildwood Drive Lateral (D01CW01014), approximately 750 feet, located west from Wildwood Drive (R01C014 and crossing Sunset Drive; Ward 1, District 3; and

3. Add Patrick Road Lateral (D02PW01030), approximately 1,900 feet, located southwest from Patrick Road (R02P030), Ward 2, District 6; and

4. Add Green Hill Drive Lateral (D02VW01001), approximately 6,680 feet, located south from Green Hill Drive (R02V001), Ward 2, District 6; and

5. Add an approximate 600 foot extension to Rosedown Way Lateral (D04DW01093), Ward 5, District 4.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
