AN ORDINANCE ESTABLISHING A SPEED LIMIT OF 35 MPH ON  
KRENTEL ROAD (7-A-4). (WARD 7, DISTRICT 7)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, the St. Tammany Parish Department of Engineering has evaluated the current speed limit on Krentel Road and have determined that the existing speed limit of 25 MPH should be increased to 35 MPH.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: in regular session convened that:

SECTION I: A speed limit of 35 MPH is hereby established on Krentel Road (7-A-4). (Ward 7, District 7)

SECTION II: The St. Tammany Parish Department of Public Works is directed to replace the existing 25 MPH signs with 35 MPH signs and other directionals signs as per the St. Tammany Parish Department of Engineering's memo attached.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

The Department of Engineering recommends the installation of Signage to be installed in District 7.

*Please make sure ALL Poles on road(s) are straight and at the right height.*

1. Replace and Raise existing STOP sign at the intersection of Krentel and Fish Hatchery.
2. Replace existing SL 25 sign north of mailbox 28123, with Speed Limit 35 sign.
3. Remove OLD SL25 and SC@P sign near mailbox 28123.
4. Remove OLD SL 25 sign from Ditch and Install Speed Limit 35.
5. Install Right Curve sign, 50' north of mailbox 28242.
6. Replace existing SL 25 sign north of Fairhope, with Speed Limit 35 sign.
7. Install Left Curve sign, 75' south of the Krentel and Fairhope.
8. Replace existing SL 25 sign on Krentel, south of the Bridge, with Speed Limit 35 sign.
9. Replace existing SL 25 sign near the Krentel T turn, with Speed Limit 35 sign.
10. Install Speed Limit 35 sign south of the T turn on Krentel Rd.
11. Add Speed Limit 35 sign to the top of existing sign on Krentel, at the 434 intersection.
