ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NO. 09-2114, ADOPTED AUGUST 7, 2009, TO APPROVE LOCATION CHANGE FOR (1) ONE POLLING LOCATION TO INCLUDE PRECINCTS CO1, CO2, CO3, C10, AND C11.

WHEREAS, La. R.S. 18:534 provides for changing of polling places; and

WHEREAS, the Parish Council Office has received notice from William Pitcher Junior High School that their gymnasium renovations are completed and they desire to re-establish their facility as a polling location; and

WHEREAS, the Parish Council would like to re-establish the polling location for Precincts CO1, CO2, CO3, C10, and C11 from Covington Elementary to William Pitcher Junior High School, located at 415 South Jefferson Street, Covington, LA 70433; and

WHEREAS, the St. Tammany Parish School Board had agreed to the use of it's Covington Elementary School, 325 South Jackson Street, Covington, LA 70433, as a polling location for Precincts CO1, CO2, CO3, C10, and C11; effective election day of November 6, 2012.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it amends Ordinance C.S. No 09-2114, adopted August 2009, to make necessary changes to voter polling locations for the convenience of voters; and to reaffirm and ratify all other current polling location; and that the Registrar of Voters is hereby directed to process notification of polling booth changes by any and all means deemed appropriate under the circumstances to individual voters in the areas affected by this change; and to be effective for voting purposes beginning November 6, 2012, subject to U.S. Department of Justice approval.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
