ORDINANCE TO APPROVE AND ESTABLISH AN AMENDED ANNUAL SALARY FOR THE ST. TAMMANY PARISH CORONER AND TO INCLUDE THE CORONER AND ALL CORONER'S OFFICE STAFF IN THE ST. TAMMANY PARISH PERSONNEL SALARY MATRIX.

WHEREAS, the St. Tammany Parish Coroner has requested a salary increase to be paid from the current 2016 Coroner's Office Budget funds; and

WHEREAS, the St. Tammany Parish Council Personnel Committee has reviewed the increased salary request; and

WHEREAS, the Parish Finance Department has reviewed the request in conjunction with the Coroner's Office Budget; and

WHEREAS, it is the desire and intent of the Parish Council to place and assign the Coroner and all Coroner's Office Staff within the Parish Personnel Salary Matrix by Labor Grade.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it approves and authorizes an amended salary for the current St. Tammany Parish Coroner, and places the Coroner within the Parish Personnel Salary Matrix at 2016 Labor Grade 19, Step 1, based on an 80 hour bi-weekly payroll, as per attached Exhibit A, effective the payroll period beginning June 26, 2016.

BE IT FURTHER ORDAINED that any future Coroner's Office Annual Budget proposing to increase the Coroner's salary in excess of one (1) Step shall require express approval by resolution of the St. Tammany Parish Council.

BE IT FURTHER ORDAINED that all staff positions of the St. Tammany Parish Coroner's Office are likewise placed within the Parish Personnel Salary Matrix by Labor Grade and according to their current annual compensation.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
