ORDINANCE TO RELOCATE PRECINCT 806 FROM GRACE
MEMORIAL BAPTIST CHURCH IN SLIDELL TO BOYET JUNIOR
HIGH SCHOOL IN SLIDELL.

WHEREAS, Grace Memorial Baptist Church, located at 58516 Pearl Acres Road, Slidell, LA 70461, is unable to renew their lease agreement to host elections beyond year 2016; therefore, precinct 806 will relocate to Boyet Junior High School, located at 59295 Rebel Drive, Slidell, LA 70461. The travel distance from the old facility to the new proposed facility is 0.8 miles. Boyet is currently utilized as a polling site for precincts 811 and 812. Boyet is ADA compliant, managed by the school board and meets all elections requirements.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that voters within Precinct 806 be relocated from Grace Memorial Baptist Church to Boyet Junior High School, effective for elections after January 1, 2017.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.



3. Turn **left** onto Stone St.

If you reach Ruby St you've gone about 0.1 miles too far.

Then 0.09 miles0.61 total mile
4. Turn **right** onto Rebel Dr.

Then 0.18 miles0.78 total mile
5. Boyet Junior High School, 59295 REBEL DR is on the **left**.

Your destination is 0.1 miles past Boyet Jr Hi Access.
Your destination is at the end of Rebel Dr.
