SECTION I: A "No Parking" zone is hereby established on a portion of Clearwood Dr (8-I-40) and E. Forest Dr, (8-I-39) as per the attached from the St. Tammany Parish Department of Engineering.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

The Department of Planning and Development recommends the installation of Signage to be installed in District 8.


- 1. Install 2 NO PARKING signs and TIME PLAQUES on each side of Clearwood Dr. 20' from the Clearwood Dr. and Eddins Pl. intersection. Install each sign so that it faces oncoming traffic as indicated on map.
- 2. Install 2 NO PARKING signs and TIME PLAQUES on each side of Clearwood Dr. between mailboxes 214 and 212 on the property lines. Install each sign so that it faces oncoming traffic as indicated on map.
- 3. Install 2 NO PARKING signs and TIME PLAQUES on each side of Clearwood Dr. between mailbox 208 and the northern most driveway of Clearwood Jr. High. Install each sign so that it faces oncoming traffic as indicated on map.
- 4. Install NO PARKING sign and a TIME PLAQUE on Clearwood Dr. just south of the northern most driveway of Clearwood Jr High as indicated on map.
- 5. Install NO PARKING sign and a TIME PLAQUE on Clearwood Dr. 12' from mailbox 205 as indicated on map.
- 6. Install NO PARKING sign and a TIME PLAQUE on Clearwood Dr. just north of the middle driveway of Clearwood Jr High as indicated on map.
- 7. Install NO PARKING sign and a TIME PLAQUE on Clearwood Dr. just south of the middle driveway of Clearwood Jr High as indicated on map.
- 8. Install NO PARKING sign and a TIME PLAQUE on Clearwood Dr. 20' from the Clearwood Dr. and E. Forest Dr. intersection, as indicated on map.



- 9. Install NO PARKING sign and a TIME PLAQUE on E. Forest Dr. across from existing No Parking sign as indicated on map.
- 10. Install NO PARKING sign and a TIME PLAQUE on E. Forest Dr. 20' east of the E. Forest Dr. and Timbers Dr. intersection, as indicated on map.
- 11. Install NO PARKING sign and a TIME PLAQUE on E. Forest Dr. directly across from the E. Forest Dr. and Timbers Dr. intersection, as indicated on map.
- 12. Install NO PARKING sign and a TIME PLAQUE on E. Forest Dr. 40' west of the E. Forest Dr. and Timbers Dr. intersection, as indicated on map.
- 13. Install 2 NO PARKING and TIME PLAQUES signs on E. Forest Dr. 20' east of the E. Forest Dr. and Whisperwood Blvd. intersection, install each sign so that it faces oncoming traffic as indicated on map.
- 14. Replace 2 TIME PLAQUES to the existing No Parking signs located on E. Forest Dr. near the Clearwood Dr. intersection.




Figure 2A-3. Examples of Locations for Some Typical Signs at Intersections
