RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR LOAD RATING INSPECTIONS OF OFF-SYSTEM BRIDGES.

WHEREAS, St. Tammany Parish Government and the City of Slidell own one or more bridges located off of the State and/or Federal road systems; and

WHEREAS, the State of Louisiana, Department of Transportation and Development, has required that Parish and City load rate off-system bridges; and

WHEREAS, Parish and City desire to enter into a Cooperative Endeavor Agreement to coordinate inspections and save costs by utilizing a single contractor to perform the load rating inspections; and

WHEREAS, Parish will procure a contractor and City shall provide payment to Parish for City's share of the cost of the work.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the City of Slidell, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the load rating of off-system bridges and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the agreement contemplated herein are hereby ratified and approved.

Resolution Administrative Comment

TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR LOAD RATING INSPECTIONS OF OFF-SYSTEM BRIDGES.

Both Parish and City have off-system bridges requiring inspections for load rating. Combining the inspections work into one project will reduce separate mobilization costs otherwise payable by Parish and City in separate load rating projects. Costs will be shared between the parties.
