RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A LIGHTING AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR INSTALLATION OF LIGHTING AT THE INTERSECTION OF INTERSTATE 10 AND OAK HARBOR BOULEVARD (WARD 9, DISTRICTS 12, 13 ).

WHEREAS, the State of Louisiana, Department of Transportation and Development ("DOTD") seeks to construct or have constructed a roadway lighting system at the intersection of Interstate 10 with Oak Harbor Boulevard, as a component of the overall intersection and to further improve safety; and

WHEREAS, DOTD desires to transfer ownership of the lighting system to Parish following installation; and

WHEREAS, St. Tammany Parish Government desires that DOTD install the lighting system and transfer same to Parish for Parish's future operation and maintenance.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Lighting Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development, for installation of a lighting system at the intersection of Interstate 10 and Oak Harbor Boulevard and to take any and all actions necessary to enter into the Lighting Agreement in support of the construction.
