Staff Comment

The current code charges \$300.00 plus court costs for any violation without a specified penalty by referencing Sec. 1-9 of the code. Amending to a specific amount would bring fines more in line with the fines charged for other traffic violations. Violations without specific penalties include, but are not limited to, driving across ditches, trespassing on detention ponds, and parking for over 48 hours.
