Administrative Comment Amendment No. 8 - 2020 Operating Budget - April 2020

This budget amendment is to:

a. 111 - PUBLIC HEALTH FUND

To amend the budget to increase expenditures for Safe Haven operations including the appointment of a Safe Haven Director.

b. 112 - ANIMAL SERVICES FUND

To amend the budget to decrease revenues based on no billings to municipalities for animal control effective January 1, 2020. To amend the budget to increase expenditures for medical services costs associated with the increase in veterinary services and the expansion of the spay and neuter voucher program, as well as for maintenance for 3 vehicles which were vandalized.

c. **507 - DEVELOPMENT FUND**

To amend the budget to increase expenditures for a vehicle and maintenance costs for the new Code Enforcement Officer position. To amend the budget to increase expenditures for a new Coastal and Environmental Program Manager position.
