ORDINANCE TO OFFICIALLY NAME THE PRIVATE 35 FOOT ACCESS SERVITUDE IDENTIFIED ON THE ATTACHED SURVEY TO MEMORY LANE.

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the private 35 foot Access Servitude has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the unnamed private road. Pending Approved Name: Memory Lane, Nearest Cross-street: Adrienne Street, Madisonville, LA 70447. Since future structures will be addressed off the newly name private 35 foot Access Servitude; the access servitude will be added to the 911 Database and to the 911 Dispatch Map.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the 35 foot Access Servitude shown on the attached survey as Memory Lane.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
