ORDINANCE TO AMEND THE ST. TAMMANY PARISH CODE  
OF ORDINANCES, CHAPTER 2, ARTICLE III, SECTION 2-030.00  
RELATIVE TO PARISH COUNCIL SALARIES.

WHEREAS, Section 2-05 (B) of the Home Rule Charter authorizes the Parish Council to change the salary of council members provided no increase in salary is adopted during the last year of a term and a change does not become effective during the current term of the council members adopting the ordinance; and

WHEREAS, it is the desire of the Parish Council to amend the monthly salary of council members beginning in the month when the new term commences in the 2012 fiscal year.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish Council amends the Code of Ordinances, Chapter 2, Article III, Section 2.030.00 relative to Parish Council salaries as follows, to-wit:

CHAPTER 2

ARTICLE III  
PARISH COUNCIL

Sec. 2-030.00 Parish Council Salaries.

The monthly compensation to be received by all elected members of the St. Tammany Parish Council shall be as follows:

A. Fiscal Year 2012 - \$ 2,400.00 per month. (Commencing the month a new term begins)

2B. Fiscal Year 2013 - \$ 2,500.00 per month.

2C. Fiscal Year 2014 - \$ 2,600.00 per month.

2D. Fiscal Year 2015 - \$ 2,700.00 per month.

2E. Monthly Compensation for subsequent years shall be \$ 2,700.00

unless amended by the Parish Council.

~~A Fiscal Year 2008 - \$ 2,000.00 per month. -B Fiscal Year 2009 - \$ 2,100.00 per month. -C Fiscal Year 2010 - \$ 2,200.00 per month. -D Fiscal Year 2011 - \$ 2,300.00 per month. -E Monthly Compensation for subsequent years shall be \$ 2,300.00 unless amended by the Parish Council. -~~

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
