a. The amount of a Warranty Obligation shall be costs for a street and supporting improvements:  Concrete Streets - \$\frac{15.00}{25.00}\$ per linear foot Asphalt Streets - \$\frac{12.00}{20.00}\$ per linear foot Gravel Streets - \$\frac{10.00}{20.00}\$ per linear foot		
b. The Planning Commission shall establish and set forth the amount of the Warranty Obligation as well as the duration Warranty Obligations shall be set for a minimum period of one (1)-five (5) years to insure serviceability and structural integrity of the street and drainage infrastructure.
