AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF ST. TAMMANY PARISH, LA, TO RECLASSIFY A CERTAIN PARCEL LOCATED ON THE NORTH SIDE OF JUDGE TANNER BLVD. EXTENSION, EAST OF WESTWOOD DRIVE AND WHICH PROPERTY COMPRISES A TOTAL 45.20 ACRES OF LAND MORE OR LESS, FROM ITS PRESENT A-1 (SUBURBAN DISTRICT) TO A PF-1 (PUBLIC FACILITIES DISTRICT). (WARD 4, DISTRICT 5) (ZC11-05-040)

WHEREAS, the Zoning Commission of the Parish of St. Tammany after hearing in accordance with the law, Case No. ZC11-05-040, has recommended to the Council of the Parish of St. Tammany, Louisiana, that the zoning classification of the above referenced area be changed from its present A-1 (Suburban District) to a PF-1 (Public Facilities District), see Exhibit "A" for complete boundaries; and

WHEREAS, the St. Tammany Parish Council has held its public hearing in accordance with law; and

WHEREAS, the St. Tammany Parish Council has found it necessary for the purpose of protecting the public health, safety and general welfare, to designate the above described property as PF-1 (Public Facilities District).

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: The zoning classification of the above described property is hereby changed from its present A-1 (Suburban District) to a PF-1 (Public Facilities District).

SECTION II: The official zoning map of the Parish of St. Tammany shall be and is hereby amended to incorporate the zoning reclassification specified in Section I hereof.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

A certain parcel of ground situated in Section 26, Township-7-south, Range -11-East, St. Tammany Parish, Louisiana and more fully described as follows
Commence at the Section Corner common to Sections 22, 23, 26, & 27, T-7-S, R-11-E, and measure North 89°20'00" East a distance of 1346.30 feet to a point Thence South 00°15'00" West a distance of 356.10 feet to a point; Thence North 89°20'00" East a distance of 512.00 feet to a point; Thence South 00°15'00" West a distance of 678.40 feet to the POINT OF BEGINNING.

From the POINT OF BEGINNING measure
North 89°20'00" East a distance of 734.89 feet to a point;
Thence South 00°15'00" West a distance of 1,570.95 feet to a point on a curve;
Thence along a curve to the right having a radius of 1,155.00 feet, a delta of 16°39'33", an arc length of 335.82 feet, and a chord which bears North 76°31'41" West having a chord distance of 334.64 feet to a point;
Thence North 68°11'55" West a distance of 1,339.08 feet to a point of curve;
Thence along a curve to the left having a radius of 1,245.00 feet, a delta of 09°24'24", an arc length of 204.40 feet, and a chord which bears North 72°54'07" West having a chord distance of 204.17 feet to a point;
Thence North 18°26'44" East a distance of 83.35 feet to a point of curve;
Thence along a curve to the left having a radius of 230.00 feet, a delta of 53°55'01", an arc length of 216.44 feet, and a chord which bears North 08°30'47" West having a chord distance of 208.54 feet to a point of tangency;
Thence North 35°28'17" West a distance of 195.59 feet to a point of curve;
Thence along a curve to the right having a radius of 170.00 feet, a delta of 22°00'00", an arc length of 65.28 feet, and a chord which bears North 24°28'17" West having a chord distance of 64.88 feet to a point;
Thence North 76°31'43" East a distance of 1,213.55 feet to a point;
Thence North 00°15'00" East a distance of 140.72 feet to the POINT OF BEGINNING, and containing 1,968,820.68 square feet or 45.20 acre(s) of land, more or less.
