ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD & DRAINAGE INVENTORIES, SPECIFICALLY VILLAGES AT BOCAGE, PHASE 1; MONTGOMERY TERRACE, PHASE 1; AND NORMANDY OAKS, PHASE 5 SUBDIVISIONS. (WARD 1, DISTRICT 1)
