Environmental Services: Jay Watson: There are no DES issues.


**Data Management: Bob Thompson:** Property is located in GMA Area1, and is undeveloped. If in the future property begins to generate Sales Tax Revenue... per the current GMA agreement 100% of revenue shall Remitted to the city.

Data Management: Bob Thompson: Blue Swamp Creek is not listed in STP Property inventory for maintenance.

**IS:** Ann Ballard: on 5/16 STP GIS contacted Covington Planning Department for confirmation regarding whether a lot marked as "excluded" in the area of interest should be included in the annexation. Covington planning department informed STP GIS that it should be included in the annexation.

Legal Department comment: The property proposed to be annexed is located within Area 1, and there is a water feature referenced as Blue Swamp Creek that runs through the property. Therefore, consistent with the Growth Management Agreement between the Parish and the City of Covington, Covington shall be responsible for the maintenance of Blue Swamp Creek, as well as any roads and drainage infrastructure within the property to be annexed.







#### ST. TAMMANY PARISH BOUNDARIES

10. 5

Foreword: St. Tammany Parish is one of the eight Parishes situated within what, prior to December 7, 1810, was known as "Floride Occidentale" (French for West Florida) the area and extent of which was shown on Bmi. Lafon's map of 1806. However, the "Floride Occidentale" district was not included as a part of the Territory of Orleans when, under an Act of the U.S. Congress, approved March 26; 1804, the Territory of Orleans was created. At that time, the northern boundary line of the Territory of Orleans, on the east side of the Mississippi River, commenced at the junction of Bayou Manchac with the Mississippi, and extended thence - in turn - along the middles of Bayou Eanchac (or Iberville River), the Amite River, Lake Maurepas, Pass Manchac, Lake Pontchartrain and the Rigolets: and continued thence castwardly on out through portions of Lake Borgne and the Mississippi Sound ( no doubt following the sinuosities of the submerged continuations of the chemols of following the sinuosities of the submerged continuations of the channels of the Rigolets and Pearl River, respectively) to the Gulf of Mexico, passing -on route - not far south of Cat Island (see the Official Map of Louisiana, 1937 Edition, for the officially established route of the submerged channel of Poarl Rivor that demarks the part of the Louisiana-Mississippi State boundary line which is claimed to extend not less than 27 miles from the recognized mouth of Pearl River to a point on the outer limit-line of the sovereign waters along the northern shore of the Gulf of Nexico). Then - in conformity with the precedent established by Act 25 of 1805, of the Logislative Council of the Territory of Orleans, when the Territory, as it existed at that time, was first of all divided into twelve (12) counties, or political subdivisions, and shortly thereafter, under the provisions of Act 1 of 1807, the said counties were superseded by nineteen (19) parishes that were also civil, or political, subdivisions - Governor Wm. C. C. Clai-borno, undor authority of a Proclamation issued by the President of the United States on October 27, 1810, proceeded to, in turn, (a) seized the district known as "Floride Occidentale"; (b) add its area to that of the Territory of Orleans; (c) issue an Ordinance on December 7, 1810, creating the County of Feliciana, out of the said added area; (d) issue a second Ordinance on December 22, 1810, dividing that portion of the said Feliciana County which was situated between the Mississippi River and Pearl River, into four parishes - under the provisions of this Ordinance of December 22, 1810 - and reserving the privilege of forming such other parishes out of the residue of Feliciana County as might thereafter be deemed expedient; (e) issue a third Ordinance on January 4, 1811, establishing two other parishes, cast of Pearl River, out of portions of the area of Feliciana

County, which were to be known thereafter as the Parishes of Bilzi and Pascagoula, respectively, and, moreover, fixing the eastern boundary of the latter Parish along Bayou Batrie so as to include within its limits the settlements on both Pascagoula Bay and Dog River, and - once more - reserving the right to form such other parishes out of the residue of the County of Feliciana as might thereafter be deemed expedient; and, (f) shift the eastern boundary of Pascagoula Parish from its position along Bayou Batrie further eastward to the Perro (also known to many persons as Dog River) which empties into Mobile Bay on the latter's western side, as shown on Catesby Graham's map of 1838, and is not to be confused with the Dog River that empties into the east side of Pascagoula Bay. Act 28 of 1811 of the Legislative Council of the Territory of Orleans not only officially confirmed the creation, by Gubernatorial Ordinances, of the six parishes out of the district, or area, that had - in turn - been known as "Floride Occidentale" and Feliciana County, but supplemented said Ordinances by definitely - in Section 6 thereof - placing within Pascagoula Parish all the area in the cestorn end of Feliciann County that had not as yot been allocated to any parish.

The boundaries of St. Tammany Parish, as created in Section 4 of. Act 28 of 1811, of the Legislative Council of the Territory of Orleans, after having been referred to and roughly described - in a preliminary way in the Ordinance by Governor Wm. C. C. Claiborne dated December 22, 1810, wore as follows, to wit: Began at a point on the boundary line between the Territory of Orleans and the Territory of Mississippi (the 31st. degree at Latitude) where the thread of the channel of the Tangipahoa River was intorsected; thence down the Tangipahoa River, following the thread of its channel in a southerly direction, until its mouth was reached; thence (no doubt) south along a direct line until the line through the middle of Lake Pontchartrain that was established in conformity with the provisions of the Act of the 12th, U. S. Congress, 1st Session, approved April 14th, 1812 (but which said line has never been surveyed) was intersected; thence eastward along the middle of Lake Pontchartrain to the thread of the channol at the west end of the Rigolets; thence - still eastwardly - through the Rigolets, following the sinuosities of the thread of its channel, to Lake Borgne; thence on east following (no doubt) the thread of the submerged channel of the Rigolets through a part of Lake Borgno until the throad of the submorged part of the channel leading from the recognized cast mouth of Pearl River through the Mississippi Sound was intersected; thence northwardly up the -Poarl River, following the sinuosities of the thread of its channel until the 31st, degree of Latitude was reached; thence due west along said boundary between the Torritory of Orleans and the Territory of Mississippi to the point of beginning, all as indicated in a general way on both Wm. Dabney's map of 1816 and Catesby Graham's map of 1838, except that said maps failed to show the line through the middles of Lake Pontchartrain and the Rigolets as the south boundary line of St. Tammany Parish.

Subsequent to its creation, the boundaries of St. Tammany Parish wore materially changed and affected; <u>first</u>, under the provisions of the Act of the Legislature that was approved March 6, 1819, which created the Parish of Washington out of the northern part of St. Tammany Parish, as the latter originally existed, and fixed the boundary line between Washington

tnd St. Tammeny Parishes. (Note - A smell part of stid dividing line situated in Section 57 of T 4 S, R 9 E - was changed by the Act approved on February 22, 1826; however, the latter Act was repealed by Act 124 of 1912, thus restoring what by then remained of said dividing line to its original position as established by the Act approved March 6, 1819); next, under Act 85 of 1869, which created the Parish of Tangipahoa out of contiguous portions of St. Tammany, Washington, St. Helena and Livingston Parishes, thereby still further reducing the area of St. Tammany Parish, and leaving it as it now exists.

The boundary lines of St. Tammany Parish as they now exist, are correctly shown on the Official Map of Louisiana, 1937 Edition, and on the quadrangle maps concerned. They are as follows, to wit: Commencing at a point in the thread of the channel of the Thhefuncta River where it is intersected by the boundary line dividing St. Tammany from Washington Parish shown on the Husser Quadrangle map as being in Section 38 of T 4 S, R 9 E. and, extending thence down the Tohefuncta River, following the sinucsities of the thread of its channel, until the range line between Ranges 9 and 10 E. is intersocted; thouce due south along said range line to and through Leke Pontchartrain until the line referred to in Section 1 of the Act of the U. S. Congress, 1st, session, approved April 14th, 1812, as being situated along the middle of Lake Pontchartrain, is intersocted; thence castward along the said boundary line in the middle of Lake Pontchartrain to a point at the west end of the Rigelets; thence through the Rigelets, still in an casterly direction, following the sinuosities of the thread of its channel to its eastern end at Lake Borgne; thence through that portion of Lake Borgne traversed eastwardly by the submerged part of the channel of the Rigolets until the submerged part of the channel of Pearl River, in the Mississippi Sound, is reached; thence northwardly up that part of the channel of Pearl River that is submerged in the Mississippi Sound until the recognized mouth of Pearl River is reached; thence up Pearl River, following the sinuosities of the thread of its channel, until the east end of the boundary line dividing St. Tammany from Washington Parish is intersected at a point opposite the middle of Section 43 of T 4 8, R 13 E., as correctly shown on Pools Bluif quadrangle; thence due west to a point on the Bogue Chitto River near the N. W. corner of Section 45 of T 4 S, R 12 E., as correctly shown on the Rio gundrangle; thence along a direct line leading slightly north of west, as portrayed on the Zona, Felsom and Husser quadrangle maps, to the point of commoncement in the Tchefuncta River.

At one time or another, the following chronologically presented Acts (copies of excerpts from which have been filed for reference further towards the back of the St. Tammany Parish boundary folio, with pertinent footnotes superimposed thereon, by your Researcher) bore either directly or indirectly on the boundaries of St. Tammany Parish, viz:

Act of the U. S. Congross (1st, Session), approved March 26, 1804, p. 1293, that .... "orected Louisiana into two torritories" .... and provided for the temporary government thereof. The Louisiana referred to therein as being divided, was the area that had previously constituted the quite spacious "Province of Louisiana". For the limits of the Territory of

Orleans so created, see Bmi. Lafon's map of 1806. It was identical with the region that in 1812 became the State of Louisiana, after the addition of the area that now embraces the eight so-called "Florida Parishes" of the State.

Act 25 of 1805, Legislative Council of the Territory of Orleans, <u>p. 144</u>, that divided the Territory of Orleans into twelve (12) counties, as shown on Bmi. Lafon's map of 1806, none of which, it will be noticed was included in the area on the east side of the Mississippi River that was situated above, or north of, a line extending in an eastorly direction from the junction of Bayou Manchae (formerly known as the Iberville River) with the Mississippi, through the middles of Bayou Manchae, the Amite River, Lake Maurepas, Pass Manchae, Lake Pontchartrain and the Rigolots - in turn - for the simple reason that no portion of the area above said line formed any part of the Territory of Orleans until after it was annexed thereto under the provisions of Governor Wm. C. C. Claiborne's Ordinance of Docembor 7, 1810.

Act 1 of 1807, Legislative Council of the Territory of Orleans, Section 9, p. 10, that - although it is now largely obsolete - simultaneously created the nineteen (19) original political parishes, none of which was in any way concerned with the area out of a part of which the Parish of St. Tammany was created by Act 28 of 1811, Legislative Council of the Territory of Orleans. Collectively, however, these nineteen (19) were the first parishes legally created as such, although - as previously explained elsowhere - the name "parish" had for many years been employed by the Catholic Church to designate the ecclesiastic areas over which each of its then widely scattered places of worship had spread its influence. Yet the proceedure followed in the case of these nineteen original Civil parishes did set a precedent that was afterwards followed in the case of the group of parishes the Territory of Orleans, to next be formed into Counties thereof, which latter subdivisions were - in turn - then suppleated by civil Parishes.

Ordinance of December 7, 1810, by Wm. C. C. Claiborno, Governor of the Territory of Orleans (bound with the Acts of 1810, p. 210), that created the "County of Feliciana", out of an area, or district of country, known up to then as "Florido Occidentale" (Western Florida) which was situated south of the Mississippi Territory, castward of the Mississippi River and extended to the Pordido (a river not far west of Pensacola Bay, as shown on Bmi. Lafon's map of 1806). Said Floride Occidentale district had been seized by Governor Claiborne, under authority of a Preclamation by the President of the United States, dated October 27, 1810; then, by Gubernatorial Ordinances, added to the Territory of Orlgans and its name changed to "County of Feliciana", thus becoming a civil, or political, subdivision of the

Ordinance of December 22, 1810, by Wm. C. C. Claiborne, Governor of the Territory of Orleans (bound with Acts of 1810, p. 120), that created four parishes, to wit; Feliciana, East Baton Rouge, St. Helona and St. Tammany Parishes, out of that part of the "County of Feliciana" lying between the Mississippi River and Poarl River; and resorved the right to form other

parishes out of the remainder of the "County of Faliciana" if deemed expedient. This Ordinance is now partly obsolete due to changes made under subsequent Acts that either created-new parishes within the area concerned or revised the boundary lines of some of those already created - all as will more fully appear in the copies of the excerpts of the pertinent Acts placed for reference, further towards the back of the St. Tammany Parish Boundary folio, and in the explanatory footnotes superimposed thereon by the Reséarcher.

Ordinance of January 4, 1811, by Wm. C. C. Claiborne, Governor of the Territory of Orleans (bound with Acts of 1811, p. 214), that created two additional parishes, out of portions of that part of the "County of Feliciane", which at that time remained cast of Pearl River, to wit: the Parishes of Biloxi and Pascagoula, the division line between the said two parishes being established along the Biloxi River, and, the castern boundary line of Pascagoula Parish being established along Bayou Batric so as .... "to include all the sottlements on Bayou Batric and the Pascagoula" .... once more reserving the right to form such other parishes out of the remainder of Feliciana County as might be deemed expedient. This Ordinance is obsolete, and the area involved is now situated within the State of Mississippi.

Ordinance of January 26, 1811, by Wm. C. C. Claiborne; Governor of the Territory of Orloans, 2nd. Session, p. 216, that shifted the eastern boundary of Pascagoula Farish from the position established in the Ordinance approved on January 4, 1811, to a new position along the Rio Perro, or Dog River, which said Dog River empties into the west side of Mobile Bay and must not be confused with the Dog River that empties into the east side of Fascagoula Bay. Catesby Graham's map of 1838 shows the location of Bayou "Batre" and of both of the streams named "Dog River".

Act 28 of 1811, Legislative Council of the Territory of Orleans, p. 120, that confirmed and made binding the Ordinances by Governor Claiborne that were issued on December 22, 1810, and January 4, 1811, respectively; which said ordinances had for their purpose the creation of the Parishes of Feliciana, East Baton Rouge, St. Eclona and <u>St. Tammany</u>, west of Pearl River, and of the Parishes of Bilexi and Pascagoula that were established east of Pearl River in districts that are new portions of the State of Mississippi. This Act 28 of 1811 is new largely obsolete, having been amended or affected in several important respects, especially with regard to the abelishment of both the Parish of Bilexi and the Farish of Pascagoula, when - under the provisions of the Act of the U. S. Congress that was approved on March 1st, 1817 - the areas concorned therewith became parts of the State of Mississippi, as well as to the subsequent creation of three new parishes within the limits of the State of Louisiann, out of portions of the Parishes of St. Helena and St. Tammany, respectively, to wit: Livingston, Tangipahoa, and Washington Parishes.

Act of the 12th, U. S. Congress (1st. Session) approved April 6, 1812, that provided for the admission of the State of Louisiana into the Union, and for the extension of the laws of the United States to the State of Louisiana, since the people within all that part of the territory, or country, designated in the Treaty at Paris on April 13, 1803, had formed

for themselves a constitution and state government, and had transmitted said constitution to Congress in conformity with the enabling Act of Congress relative thereto.

Act of the 12th, U. S. Congross (1st. Session) approved April 14, 1812, that provided for the enlargement of the State of Louisiana, in case the state legislature thereof gave official consent to said enlargement. The territory, ar area, proposed as the said enlargement, being a portion of the district known prior to 1810 as "Floride Occidentale", then as "Feliciana County" for a short while, and was situated as follows, to wit: ... "Beginning at the junction of the Iberville with the Mississippi; thence along the middle of the Iberville, the River Amite, and the Lakes Maurepas and Pontchartrain, to the eastern mouth of Pearl River to the thirty-first degree of latitude, to the Mississippi; thence down said River, to the place of beginning." ....

Act 1 of 1812, (1st. Session) Louisiana State Legislature, p. 4, that was in the form of a Resolution of the Louisiana State Legislature giving assent to the enlargement provided for in the Act of the 12th, U. S. Congress (1st. Session), thus making the enlargement of the State - as above provided for in the Act of the U. S. Congress approved on April 14, 1812 both logal and binding; and, moreover serving to control boundaries in certain landlocked lakes and other water bodies.

Act of the U. S. Congress, Chapter XXIII, p. 120, approved March 1st, 1817, that enabled the people of the western part of the Territory of Mississippi to form a constitution and state government, and also provided for the admission of such a state into the Union on an equal footing with the original states; thus, abelishing the Parishes of Biloxi and Pascagoula as subdivisions of the so called County of Feliciana (formerly known as Floride Occidentale) and making it possible for the areas concerned therewith to become political subdivisions of the State of Mississippi and be designated as Counties thereof.

Act of the Louisiana State Legislature, approved March 6, 1819, p. 80, that created the Parish of Washington, out of the northern part of St. Tammany, and established the dividing line between the said two parishes. This Act is now obsclete in part, having been amended or affected by the following Acts, to wit: The Act approved February 22, 1828 (afterwards repealed); Act 85 of 1869; Act 124 of 1912 (that ropealed the 1826 Act); and, Act 82 of 1932 that supplemented Act 1 of 1812 relative to the boundary line through Lake Pontchartrain and other landlocked water bodies, where the lines at the middles of such water bodies no doubt serve as boundaries between states, as well as between political subdivisions thereof, except under certain special circumstances. (Note - such an interpretation of the application of said Act 82 of 1932 to St. Tammany Parish provides St. Tammany with a south boundary line that is common - in turn - to the Parishes of St. Jamos, Jefferson, Orleans and even St. Bernerd.)

Act approved February 22, 1826, p. 38, that purported to determine that part of the boundary line dividing St. Tammany Parish from Washington Parish that was situated on the Strawberry Bluff and was believed in 1826 to include the domicile of Richard S. Chappel, by following his north and east boundary lines. However, the doubts relative thereto must have again arisen in 1912 when Act 124 of 1912 repealed the Act that had been approved on February 26, 1826, and restored the Act that had been approved on March 6, 1819 as the provailing Act, thus placing the location of the said boundary where it crosses the Bogue Chitto River at about the middle of Section 57 of T 4 S. R 12 E, as shown on the Rio Quadrangle map.

Act 85 of 1869, p. 83, that created the Parish of Tangipahoa, out of the contiguous portions of the parishes of Washington, St. Tammany, St. Helena, and Livingston, as those parishes then existed. This 1869 Act still provails, except for the change in that part of the Tangipahoa-Washington Parish boundary line which had been described (in a general way) as following the western bark of the Tchefuncta River (evidently through Sections 6, 7 and 8 of T 2 S, R 9 E.) .... "to the headwaters of the Tchefuncta River" .... but that was presumedly revised later on by agreement between the police juries of Tangipahoa and Washington Parishes, in the manner pertrayed on the Sunny Hill Quadrangle Map, in order, no doubt, to avoid having to assess the land of some of the owners there, in two parishes instead of only one.

Act 124 of 1912, p. 146, that repealed the Act approved on February 22, 1826, which related to the boundary line between the Parishes of Washington and St. Tammany; and, in lieu thereof established the said dividing line through Section 57 of Township 4 South, Rango 12 East (the Richard Chappel Headright) all as correctly shown on the Rie and Zona quadrangle maps, as well as on the Official Map of Leuisiana, 1937 Edition. This Act maps, as well as on the Official Map of Leuisiana, 1937 Edition. This Act 124 of 1912 still prevails, except that the dividing line between St. Tammany and Washington Parishes new extends only as far west as the Tchefuneta River owing to the creation of Tangipahea Parish under the provisions of Act 85 of 1869.

Act 82 cf 1932, p. 341, that, among other things, defined the boundary lines of the City of New Orleans (as well as of the Parish of Orleans) as being located, in part, in conformity with the provisions and intent of the Act of the U. S. Congress approved April 14, 1812, nemely: along the middles of certain lakes, landlocked water bedies and streams, such as Lakes Pentohartrain and Maurepas, the Rigelets and etc., where said middle locations ordinarily represent the limit of jurisdiction of civil, or political, subdivisions fronting on such water bodies.
