AN ORDINANCE TO ESTABLISH A NO PARKING ZONE ON C.L. PARKER ROAD . WARD 9, DISTRICT 14.

WHEREAS, the Department of Public Works finds it necessary to impose a no parking zone to prohibit the parking of vehicles within the rights of way of C.L. Parker Road (R09D052) for the entire length of said road (approximately 205 feet), to protect the health, safety and well being of motorists traversing said roadway.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that It hereby establishes a "No Parking" zone on C.L. Parker Road (R09D052). Ward 9, District 14.

BE IT FURTHER ORDAINED, that the Department of Public Works is authorized and directed to place a sign effectuating said No Parking zone at 37308 CL Parker Road.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
