ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE STATE ROUTE LA 3228 (ASBURY DRIVE) FROM THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (WARD 4, DISTRICT 5).

WHEREAS, pursuant to Resolution Council Series No. C-3462, St. Tammany Parish Government agreed to accept ownership of whatever rights the State of Louisiana, Department of Transportation and Development may own in State Route LA 3228 (Asbury Drive) in its entirety from its intersection with the East Service Road State Rouge US 190 known as North Causeway Boulevard proceeding southeast and approximately 0.65 miles to its intersection with State Route US 190 (Emerald Drive), following the completion of certain constructions which are now satisfied; and

WHEREAS, Parish desires to acquire State Route La 3228 (Asbury Drive) and authorizes the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire Asbury Drive from the State of Louisiana, Department of Transportation and Development.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany, through the Office of the Parish President, to acquire, by Act of Transfer and Acceptance from the State of Louisiana, Department of Transportation and Development, State Route LA 3228 (Asbury Drive) in its entirety from its intersection with State Route US 190 East Service Road known as North Causeway Boulevard proceeding southeast approximately 0.65 miles to its intersection with State Route US 190 (Emerald Drive), inclusive of the traffic signal at the intersection of State Route LA 3228 with local roads Desoto Street and Sharp Road.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
