ORDINANCE ESTABLISHING A NO PARKING ZONE ON A PORTION OF GLENDALE HEIGHTS DRIVE.(4-D-183) (WARD 4, DISTRICT 5) (GOULD)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: A "NO PARKING" zone is hereby established on Glendate Heights Drive (R04D183).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations, in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.


The Department of Engineering recommends the installation of Signage to be installed in District 5.

1. Install "NO PARKING" sign with Left Arrow and "NO PARKING" sign with Right arrow on Glendale Heights Dr. 20' from the Glendale and Sharp intersection. Please be sure that there is one sign on each side of Glendale Heights and the arrows are facing Away from sharp.

2. Install "NO PARKING" sign with Left Arrow and "NO PARKING" sign with Right arrow on Glendale Heights Dr. 100' from the Glendale and Sharp intersection. Please be sure that there is one sign on each side of Glendale Heights and the arrows are facing towards sharp.

Please install signs in accordance with MUTCD standards and see the attached sketch. Thank you for your assistance. If you have any questions, please let me know.
