ORDINANCE TO IMPOSE A SIX (6) MONTH MORATORIUM ON THE ISSUANCE OF BUILDING PERMITS FOR PLACEMENT OF MANUFACTURED HOMES AND MOBILE HOMES ON PROPERTY SITUATED IN SECTION 14, TOWNSHIP 5 SOUTH, RANGE 11 EAST. (WARD 2, DISTRICT 2)

WHEREAS, on May 5, 2011 the Parish Council adopted an emergency 30-day moratorium on the issuance of building permits for the placement of manufactured homes and mobile homes in the area described as Section 14, Township 5 South, Range 11 East; and

WHEREAS, in order to protect and preserve the health, safety, welfare and property interests of the property owners and residents residing in the area described as Section 14, Township 5 South, Range 11 East, it is necessary to impose a moratorium on the issuance of building permits for placement of manufactured homes and mobile homes in said area in order to provide an opportunity for the Zoning Commission to review and evaluate the Manufactured Housing Overlay (MHO) designation for the particular area and thereafter make its recommendations to the Parish Council for final action. Section 14, Township 5 South, Range 11 East is the area bounded on the east by King Road, on the north by Fairhaven Road, on the west by Lee Road and on the south by Section line 14.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that in accordance with Section 2-14 of the Home Rule Charter, the Parish Council imposes a six (6) month moratorium on the issuance of building permits for placement of manufactured homes and mobile homes on property within the area described as Section 14, Township 5 South, Range 11 East. (Ward 2, District 2)

BE IT FURTHER ORDAINED that this Ordinance shall be effective immediately upon final adoption and shall remain in effect through December 1, 2011.

BE IT FURTHER ORDAINED that the moratorium imposed may be vacated, in whole or in part, by Resolution of this governing body pursuant to Chapter 5, Article II, Section 5-056.00 of the Parish Code of Ordinances.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
