INTRODUCED BY:

AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE BIVINS ROAD, MONTERY POND, BULL RUN LATERAL, EAST POWERLINE ROAD LATERAL, WEST CHERRYWOOD LANE LATERAL, AND AN EXTENSION TO BESSIE BOOTH ROAD. (WARDS 2, 4, 8 & 9) (DISTRICTS 3, 6 & 10)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

## THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Bivins Road - approximately 500 feet, located east from Hill Road, Ward 2, District 3; and

2. Add Montery Pond - 3.254 acres, located on Square 179, Town of Mandeville, Ward 4, District 10; and

3. Add Bull Run Lateral, located parallel with Bull Run to the Lowe Pond, Ward 9, District 6; and

4. Add East Powerline Road Lateral - located south from East Powerline Road to the Lowe Pond, Ward 8, District 6; and

5. Add West Cherrywood Lane Lateral - located parallel with West Cherrywood Lane to the Lowe Pond, Ward 8, District 6; and

6. Add an extension to Bessie Booth Road (R02J013) approximately 2,550 feet east,Ward 2, District 3.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
