ORDINANCE ESTABLISHING THE PLACEMENT OF A "DO NOT ENTER" SIGN ON WESTWOOD DRIVE WITH ITS INTERSECTION WITH SHARP ROAD AT THE ENTRANCE TO WESTWOOD ESTATES SUBDIVISION. (WARD 4, DISTRICT 5)

WHEREAS , the St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase of traffic traversing the Westwood Subdivision due to church activities at certain times thereby increasing the safety concerns of the citizens of the area warranting establishing a " Do Not Enter - Church Traffic- Sundays 8:00 A. M. To 11:00 A. M." sign at the Sharp Road entrance to Westwood Estates Subdivision to assist with traffic control; and

WHEREAS, affected citizens have requested measures be taken to address this traffic control issue at said location.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

Section I: A " Do Not Enter - Church Traffic - Sundays 8:00 A. M. To 11:00 A. M." sign is established at the Sharp Road entrance to Westwood Estates Subdivision. ( Ward 4 District 5)

Section II: The Parish Department of Public Works is directed to post the appropriate sign at said location.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
