ORDINANCE TO DECLARE LOT 13, SQUARE 6, BAUDOT PLACE SUBDIVISION AS SURPLUS TAX-ADJUDICATED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO HABITAT FOR HUMANITY ST. TAMMANY WEST (WARD 4, DISTRICT 10).

WHEREAS, the Parish of St. Tammany owns property described as Lot 13 of Square 6 in Baudot Place Subdivision (the "Property"), said property having been adjudicated to St. Tammany Parish for unpaid property taxes; and

WHEREAS, the Parish Council, through Ordinance Council Series No. 12-2757, partnered with Habitat for Humanity St. Tammany West ("Habitat") to help create affordable housing ownership by donating Habitat-identified properties to Habitat for construction of affordable workforce housing; and

WHEREAS, Habitat has identified the Property as desirable for Habitat's use in creating affordable housing; and

WHEREAS, the Parish of St. Tammany desires to donate the Property to Habitat for Habitat's use in creating affordable housing in accordance with the disposition of adjudicated property procedures provided by Louisiana Revised Statutes Section 47:2196, et seq. and also as authorized by Louisiana Constitution Article VII, Section 14(B), Louisiana Revised Statutes section 47:2205 and Louisiana Revised Statutes Section 33:4717.3.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish Council declares the tax-adjudicated Lot 13, Square 6, Baudot Place Subdivision as surplus property and authorizes the donation to Habitat for Humanity St. Tammany West in accordance with the disposition of adjudicated property procedures provided by Louisiana Revised Statutes Section 47:2196, et seq.

BE IT FURTHER ORDAINED, that the Parish President is authorized to sign any and all documents necessary to effectuate the donation of Lot 13, Square 6, Baudot Place Subdivision to Habitat for Humanity St. Tammany West.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

### **Ordinance Administrative Comment**

ORDINANCE TO DECLARE LOT 13, SQUARE 6, BAUDOT PLACE SUBDIVISION AS SURPLUS TAX-ADJUDICATED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO HABITAT FOR HUMANITY ST. TAMMANY WEST (WARD 4, DISTRICT 10).

Lot 13 in Square 6 of Baudot Subdivision was adjudicated for non-payment of 1992 taxes. Habitat for Humanity St. Tammany West has identified the property as being desirable to Habitat for acquisition and subsequent construction of affordable housing. Parish Counsel had previously adopted ordinance Council Series No. 12-2757 to establish a program for donating adjudicated properties to Habitat.
