RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO THE LOCAL SERVICES LAW, LA R.S. 41:1291 AND HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH NORTHSORE TECHNICAL COMMUNITY COLLEGE FOR THE USE OF CLASSROOM SPACE AT THE KOOP DRIVE ADMINISTRATIVE COMPLEX (WARD 4, DISTRICT 5).

WHEREAS, Northshore Technical Community College ("NTCC") provides technical and academic education needed to assist individuals in making informed and meaningful occupational choices by training Louisiana's workforce to be employable at entry and advanced levels; and

WHEREAS, NTCC desires usage of two classrooms in Building B of the Parish's Koop Drive Administrative Complex; and

WHEREAS, Parish desires to provide NTCC with use of two classrooms as part of its education mission.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to the Local Services Law, La R.S. 41:1291 and Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the Northshore Technical Community College for the use of two classrooms at the Koop Drive Administrative Complex, and to take any and all actions necessary in support of same;

BE IT FURTHER RESOLVED, that all actions previously taken by the Office of the Parish President are ratified and accepted accordingly.
