ORDINANCE TO ACCEPT ONE OR MORE ACT(S) OF DEDICATION AND DONATION OF PROPERTY FOR THE FUTURE IMPROVEMENT AND CONSTRUCTION OF THE CHRISTWOOD BOULEVARD EXTENSION, AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH (WARD 1, DISTRICT 1).

WHEREAS, as authorized through the adoption of St. Tammany Parish Resolution Council Series No. C-4796 on April 6, 2017, St.Tammany Parish Government ("Parish") has entered into a Cooperative Endeavor Agreement (the "Agreement") with Christwood, River Chase Shopping Center, L.L.C. ("River Chase"), Christ Episcopal School ("CES") and Christ Episcopal Church of Covington, Louisiana ("CEC") for the construction and extension of Christwood Boulevard to Brewster Road, and related transactions and improvements (the "Christwood Boulevard Extension"), for which all Parties have incurred and/or will incur certain obligations and responsibilities therein; and

WHEREAS, the Christwood Boulevard Extension, as designed and implemented, would serve to improve traffic flow and safety within the vicinity of Christwood Boulevard and Louisiana Highway 21; and

WHEREAS, pursuant to the foregoing Agreement, and in consideration of Parish's obligations therein, Christwood, River Chase, CES and/or CEC (the "Owners") have agreed to dedicate and donate to and for the benefit of Parish, and Parish has agreed to accept, certain parcels of immovable property which comprise, in whole or in part, the right of way for the Christwood Boulevard Extension, and/or related improvements thereto, and which property is more fully described on Exhibits "A," "B" and "C" attached hereto (the "Property"); and

WHEREAS, given the foregoing, there is a need and a public purpose for the acceptance of the Property for the future improvement and construction of the Christwood Boulevard Extension, which project will benefit Parish citizens, and it is accordingly in the best interest of Parish citizens to accept the dedication(s) and donation(s) of said Property; and

WHEREAS, in the event that the improvements and obligations concerning the Christwood Boulevard Extension are terminated pursuant to the Terms of the Agreement and/or by operation of law, the Agreement obligates Parish to revoke the dedication and donation of the Property as accepted and transfer the same back to the Owners as more fully detailed therein.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: the St. Tammany Parish Council accepts one or more Act(s) of Dedication and Donation of the Property into the Parish road maintenance system inventory, which Property is more fully described on Exhibits "A," "B" and "C" attached hereto.

BE IT FURTHER ORDAINED: that the Parish President is hereby authorized to exercise its discretion in acquiring the Property, together with execution of any and all documents necessary to perfect the dedication, donation, transfer and acceptance authorized herein.

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire said Property.

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized and instructed to proceed with the acquisition of the Property in a timely and orderly manner.

BE IT FURTHER ORDAINED: that pursuant to the Agreement and all applicable provisions of law, the Office of the Parish President, and only upon the termination of the Agreement and/or upon non-fulfillment of pertinent conditions and obligations of Parish and/or the Owners therein, is directed and authorized to assess, deem, designate and determine that the Property is surplus and/or to transfer and/or dispose of said Property back to the Owners and pertinent predecessor(s) in title.

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
