AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE RIVER ROAD LATERAL; SLATCHERY ROAD; STEPHANIE LANE, TRAVIS CORE LATERAL; JIM CORE ROAD LATERAL; AND HENRY CLAY STREET. WARDS 1, 2, 3 & 4, DISTRICTS 2, 3 & 10

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include River Road Lateral (D03HW04001), approximately 2,770 feet, located east off Highway 25, Ward 3, District 2; and
2. Include Slatchery Road, approximately 2,600 feet, located south off Highway 1078, Ward 3, District 3; and
3. Include Stephanie Lane, approximately 990 feet, located east off Highway 1077, Ward 1, District 2; and
4. Include Travis Core Lateral (D02JW01016), approximately 500 feet, located south off Travis Core Road (R02J016), Ward 2, District 3; and
5. Include Jim Core Road Lateral (D02MW02008), approximately 480 feet, located south off Jim Core Road (R02M008), Ward 2, District 3; and
6. Include Henry Clay Street (R04D299), approximately 300 feet, located east and west off Coffee Street (R04D047), Ward 4, District 10.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
