ORDINANCE TO DECLARE CONDO UNIT 135 KINGSPOINT VILLAGE CONDOMINIUMS (173 KINGSPOINT BLVD., SLIDELL, LA) AS SURPLUS TAXADJUDICATED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO THE KINGSPOINT VILLAGE CONDOMINIUM HOMEOWNERS ASSOCIATION, INC. (WARD 8, DISTRICT 13, 14)

The property was adjudicated for non-payment of 2008 taxes. The abandoned condition of the property, along with multiple association liens, claims and/or judgments, has been an issue for its neighbors for several years. Donating the property to the association will provide association with greater options for alleviating the condition and/or returning the property to commerce. Donations of adjudicated property are allowed as per LSA R.S. 47:2201 and 47:2205.
