TO RELOCATE THE POLLING LOCATION FOR PRECINCTS 418 AND 429 FROM GRACE DISCIPLES IN COVINGTON, LA TO THE NORTHSHORE PASTORAL CENTER OF THE ARCHDIOCESE OF NEW ORLEANS LOCATED IN COVINGTON, LA.

WHEREAS, the current polling location for Precincts 418 and 429 at Grace Disciples, 975 Hwy. 190 East Service Road, Covington, LA 70433 is in the process of selling their facility; therefore, they will no longer be able to host election day voting. A new polling site has been secured at The Northshore Pastoral Center of the Archdiocese of New Orleans, bearing physical address 4465 Hwy. 190 East Service Road, Covington, LA 70433. The facility is compliant with the (ADA), American Disability Act.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: the polling location for Precincts 418 and 429 be relocated from Grace Disciples, 975 Hwy. 190 East Service Road, Covington, LA 70433 to The Northshore Pastoral Center of the Archdiocese of New Orleans located at 4465 Hwy. 190 East Service Road, Covington, LA 70433, a distance of .45 miles, effective immediately upon approval.

BE IT FURTHER ORDAINED that: The Northshore Pastoral Center will begin hosting elections for the November 8 and December 10, 2016 election dates.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
