## **Ordinance Administrative Comment**

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXTEND A LEASE ON OFFICE SPACE IN THE KOOP DRIVE ADMINISTRATIVE COMPLEX TO THE STATE OF LOUISIANA, DEPARTMENT OF ENVIRONMENTAL QUALITY.

This Ordinance is to allow Parish Government to lease 484 square feet office space in Building C of the Parish's Koop Drive Administrative Complex. Rent charged will be equivalent to the rate charged to other State lessees in the Koop Drive Administrative Complex.
