WHEREAS, St. Tammany Parish Government owns and operates the Westwood Sewage Treatment Facility; and

WHEREAS, the Louisiana Pollutant Discharge Elimination System (LPDES) permit which authorizes effluent discharge from the Westwood Sewage Treatment Facility mandates the Parish to institute a program directed towards pollution prevention in order to improve operating efficiency and extend the useful life of the treatment facility; and

WHEREAS, as part of Other Conditions, Section H of LPDES permit LA0063991, the Parish Government must complete an annual Environmental Audit Report for the life of the permit.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the St. Tammany Parish Council acknowledges the receipt of the 2016 Municipal Water Pollution Prevention Environmental Audit Report for the Westwood Sewage Treatment Facility and its finding that no actions are necessary at this time for compliance achievement.
