RESOLUTION TO AUTHORIZE THE APPOINTMENT OF AN  
INTERIM LOCAL COASTAL PROGRAM ADMINISTRATOR FOR  
ST. TAMMANY PARISH AND TO PROVIDE FOR RELATED  
MATTERS.

WHEREAS, The Louisiana State and Local Coastal Resources Management Act provides for the establishment of a local coastal zone and a Local Coastal Program Administrator to implement local coastal zone management provisions; and

WHEREAS, St Tammany Parish Government has enacted the St Tammany Parish Coastal Zone Management Ordinance to be implemented by an interim local coastal program Administrator; and

WHEREAS, St. Tammany Parish Government is currently advertising to hire a Coastal and Environmental Program Manager that will serve as the Local Coastal Program Administrator.

WHEREAS, St. Tammany Parish Government seeks to appoint Sabrina Schenk to act as the interim Local Coastal Program Administrator for purposes of administering the St. Tammany Parish Coastal Zone Management Ordinance in accordance with the State and Local Coastal Resources Management Act and regulations pertaining thereto, namely, LAC Title 43 until the position has been filled.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the St. Tammany Parish Council Approve the appointment of Sabrina Schenk to act as the interim local coastal program Administrator and to implement the St. Tammany Parish Coastal Zone Management Ordinance in addition to the State and Local Coastal Zone Resource Management act and implementing regulations.
