

Ordinance Administrative Comment

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE BY DONATION A CERTAIN PARCEL ALONG LITTLE BAYOU CASTINE (WARD 4, DISTRICT 7).

The Parish seeks to acquire by donation property to be subdivided as Lot 1-D in Square 218 of Town of Mandeville Subdivision. Little Bayou Castine traverses through Lot 1-D, and Parish's Department of Public Works desires ownership of Lot 1-D for drainage purposes. The property will be donated without Parish paying any compensation for the property.
