ORDINANCE TO OFFICIALLY DEDICATE AND NAME THE ST. TAMMANY PARISH FAIRGROUNDS' MIDWAY TO DENNIS SHARP CIRCLE IN HONOR OF THE FORMER AND LATE DISTRICT 2 PARISH COUNCILMAN MR. DENNIS SHARP; AND TO IMPLEMENT HONORARY IDENTIFIERS ALONG SAID ROADWAY. (FITZGERALD)

WHEREAS, the St. Tammany Parish Council would like to honor the late Councilman Frank Dennis Sharp by naming the Midway at the St. Tammany Covington Fairgrounds, located in Parish Council District 2, "Dennis Sharp Circle." Mr. Sharp was a lifetime resident of Covington and an instrumental contributor of activities associated with the Fairgrounds, including the 4-H Club, Future Farmers of America, agricultural and recreational activities; and

WHEREAS, the St Tammany Parish 911 Communications District has received, reviewed, and approved the Road Name Request Form for the unnamed private road. Pending Approved Name: DENNIS SHARP CIR, Nearest Cross-streets: E MAGEE ST, Covington, LA 70433. No current, nor future, structures will be addressed off of the newly named road; therefore, the road will NOT be added to the 911 Database but will be added to the 911 Dispatch Map; and

WHEREAS, the St. Tammany Fairgrounds Advisory Board unanimously voted in favor of the proposed naming of the Fairgrounds' Midway at their February 2019 board meeting.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the St. Tammany Parish Fairgrounds' Midway to "Dennis Sharp Circle" and implement signage identifiers along said roadway.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
