AN ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 28 OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE III WATERWAYS, DIVISION 2 WATERCRAFT SPEED LIMITS, SECTION 28-121(A)(1)B. OPERATION: SPECIAL **SPEED** LIMITS: DEFINITIONS, UNLAWFUL OPERATION, TCHEFUNCTE RIVER AREA, TO EXTEND A DEAD SLOW, NO WAKE ZONE ON A PORTION OF THE TCHEFUNCTE RIVER (WARD 1, DISTRICT 4)

WHEREAS, in the interest of public safety, health and general welfare, it is necessary to extend an existing "Dead Slow, No Wake" zone for a portion of the Tchefuncte River beginning at a line across the river at a point 200 feet north of an inlet off the river commonly known as High Bridge Canal and extending 0.5 miles downstream to the mouth of the river at Lake Pontchartrain.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it amends Parish Code of Ordinances, Chapter 28 Offenses and Miscellaneous Provisions, Article III Waterways, Division 2 Watercraft Speed Limits, Section 28-121(a)(1) Operation; special speed limits; definitions, Unlawful operation, Tchefuncte River area to extend a "Dead Slow, No Wake" zone on a portion of the Tchefuncte River, amending subsection b. to be read as follows:

b. A portion of the Tchefuncte River beginning at a line across the river at a point 200 feet north of an inlet off the river commonly known as High Bridge Canal, and extending 0.5 miles downstream to the mouth of the river at Lake Pontchartrainto a line across the river at a point 100 feet south of the High Bridge Canal.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
