ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO PURCHASE OR OTHERWISE ACQUIRE A CERTAIN PARCEL COMPRISING THE CARDINAL COVE PORTION OF THE SAFE HAVEN CAMPUS (WARD 4, DISTRICT 7)

WHEREAS, St. Tammany Parish Government desires to acquire certain immovable property, consisting of approximately 45.391 acres plus improvements, which is commonly known as the "Cardinal Cove" portion of the Safe Haven Campus; and

WHEREAS, there is a public need and public purpose for acquisition of Cardinal Cove; and

WHEREAS, the purchase price for Cardinal Cove shall not exceed the fair market value as determined by an appraisal; and

WHEREAS, Parish desires to utilize Cardinal Cove for continuation of mental health services complimentary to the Safe Haven Campus.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire 45.391 +/- acres plus improvements comprising the Cardinal Cove portion of the Safe Haven Campus and as depicted on the plan attached hereto (the "Property"); and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to do whatever is necessary to acquire the Property, plus any necessary servitudes and/or any other agreements and transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that the purchase price shall not exceed the fair market value of the Property as determined by an appraisal of the Property; and

BE IT FURTHER ORDAINED: that any actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

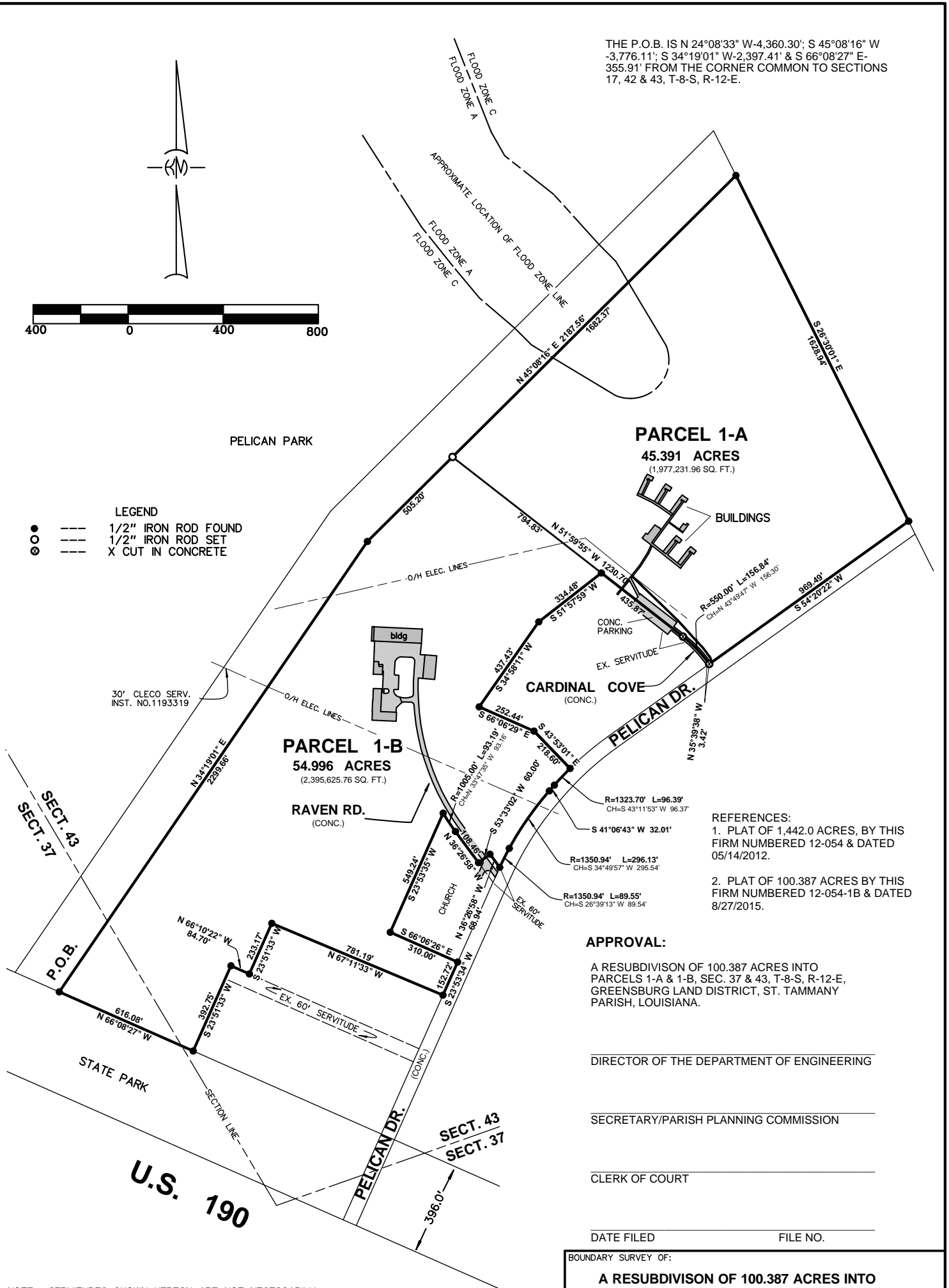
