ORDINANCE TO ENACT ARTICLE XVI, SECTION 16-131.04 OF THE ST. TAMMANY PARISH CODE OF ORDINANCES SETTING UP RATES FOR THE USE OF TAMMANY TRACE FACILITIES

WHEREAS, Tammany Trace facilities have expanded and include certain facilities that are in demand for use for private functions; and

WHEREAS there is a need to establish a set of uniform rates concerning the use of these facilities by the citizens and organizations of this Parish; and

WHEREAS it is imperative that the Parish of St. Tammany be able to apply rates uniformly.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Code of Ordinance, Chapter 16, Section 16-101.04 be enacted to include rates for the use of Tammany Trace facilities as follows:

A) MOBILE STAGE TRAILER

The Map 24 Mobile Stage Trailer ("Stage"), is available to rent at a rate of Five Hundred (\$ 500.00) Dollars per event. Additional terms and conditions, including insurance requirements, will be set forth in a User Agreement which must be completed prior to the event. Proof of the required insurance must be produced prior to any use of the Stage.

B) THE TRACE

If the entire length of the Trace is being used for an event, the rate shall be Four Hundred Fifty (\$ 450.00) Dollars per day. If the event will not use the full length of the Trace, the rate shall be Two Hundred (\$ 200.00) Dollars per day. Additional terms and conditions, including specific portion of the Trace to be used and insurance requirements, are to be set forth in a User Agreement which must be completed prior to the event. Proof of the required insurance must be produced prior to any use of the Trace.

C) KOOP DRIVE AREA

The deck areas behind the caboose are available to rent at the rate of Seventy-Five (\$ 75.00) Dollars for a two hour period. Covered areas 1 & 2, across from the playground are available to rent at the rate of Fifty (\$ 50.00) Dollars for a two hour period. The Kid's Town Pavilion is available to rent at the rate of Seventy-five (\$ 75.00) Dollars per hour, with a two hour minimum. Additional terms and conditions, including insurance requirements, will be set forth in a User Agreement which must be completed prior to the event. Proof of the required insurance must be produced prior to any use of the Koop Drive Area Facilities.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
